This Cookie Policy applies to all accesses regardless of the technology or method used to connect to the website. #### What are Cookie Practices?

Cookies are small data sent to your browser by the website you visit. Cookies enable the website to remember information about your visit. Cookies are necessary and important because they make the website useful and facilitate web descriptions.

# For What Purposes Are Cookies Used?

One of the purposes of using cookies is the need for technical data to ensure effective use of the website. Cookies are also used to collect statistical data on how the website is used and to improve the content of the website and improve its operation. Users are provided with convenience thanks to the use of cookies on the website.

### What are the Functions and Use of Cookies?

- Cookies are small files saved on your desktop or laptop computer or mobile device from the website you visit. In this way, it can be determined, for example, whether a connection has been previously established between your device and our website or which language or setting is preferred. Cookies may also contain personal information.
- When you use our website, you also accept the use of cookies. However, you can also use our website without accepting the use of cookies. You can refuse the use of cookies and delete cookies at any time by making the relevant setting on your device.
- If the use of cookies is rejected, some features of our website may not be available or their functions may be restricted.

## What Types of Cookies Are Used?

Different types of cookies are used on the website. Cookies in terms of their source; first party cookies and third party cookies.

**First-party cookies:** These are cookies placed directly on visitors' devices by the website and defined by the website you are visiting, which can only be read by this site.

**Third-party cookies:** Defined by other organizations used for different services. The external analytical services we use and the suppliers that offer this service (Google Analytics) are examples of this and are used to distinguish users who visit our website.

The cookies used at <a href="https://www.erdemaslan.av.tr">https://www.erdemaslan.av.tr</a> can be classified as follows:

**Necessary Cookies:** These cookies are essential to ensure the correct and proper functioning of your system and allow you to navigate our website and use our features. For example, remembering previous actions

when going back to a page in the same session. These cookies do not recognize you as a separate person or identify you. If you do not accept these cookies, this may affect the performance of the website.

Google Analytics Cookie: Thanks to these cookies, information is obtained about how you use our website. Google Analytics provides the information we need to improve your experience of our website and deliver the content you find most useful. Google Analytics cookies record detailed information about which pages you visited on our website, how long you spent, where you reached our website, and what content you clicked on. Thanks to the information provided by Google Analytics, we can examine the flow on our website, identify areas that need improvement and offer you a much better experience. These cookies do not collect or store users' personal information. Therefore, this information cannot be used to identify and/or identify individuals.

#### **How Can You Delete Cookies?**

Many internet browsers automatically accept cookies. It is possible for the user to change these settings, block cookies, or change the settings on how to change the indicator when a cookie is sent. However, if cookies are blocked by the user, you may not be able to use all parts of the website. You can refer to your browser's help menu for more detailed information on deleting or blocking cookies. If you access the website from different devices (mobile, tablet, computer, etc.), you must also adjust cookie settings for all devices.

Google Chrome: After opening Chrome, the user must click on the "More Settings" button at the top right and then click on the "Advanced" button. From here, click on the "Content Settings" button in the "Privacy and Security" section and then click on "Cookies" and you can delete it by clicking on the "All Cookies and Site Data" section under our website.

Safari: When you click on "Preferences" and then "Privacy" in the "Safari" section of the registration, you will see "Website Data". Deploy one or more sites by clicking this button and then you can click "Delete "Delete All".
